- ◆ Training and Education The Association conducts two statewide conferences, one seminar, two webinars and over 25 training events each year. The Fogarty Training Center was created in response to the need for up-to-date, high quality training for stormwater field staff in your area to save travel costs. - ◆ Communications and Information Sharing The FSA Stormwater Utilities Survey is conducted and distributed every two years. An abbreviated listing of current stormwater rates is updated frequently. 

Introduction

This Report presents the results of the Association's 12th biennial Stormwater Utilities Survey in Florida. Its purpose is to provide information to both managers and policy-makers in state and local government. Trends in the characteristics of the stormwater programs, utility rates and other practices within local government can now be observed by comparing survey results through 2018.

Florida has 67 counties and over 410 cities. Short of surveying *every* city and county, it is difficult to determine exactly how many stormwater utilities exist in the state. FSA's best estimate is that there are now approximately 165 local governments that have established stormwater utilities pursuant to Chapter 403, Florida Statutes or their own home rule powers. 137 stormwater utilities responded to the 2018 survey questionnaire.

We expect the number of stormwater utilities to continue to increase for several reasons: The Florida Supreme Court has consistently upheld the validity of such fees; there is (generally) more public support for funding programs with user fees as opposed to ad valorem or other general taxes; and, the process of implementing Numeric Nutrient Criteria and the multi-billion dollar Total Maximum Daily Load program in Florida continue to drive costs higher.

As one might expect, service areas dedicated exclusively to cities constitute a significant majority of stormwater utilities in part reflecting the relative ease of attaching a user charge onto an existing billing mechanism. Most stormwater utilities are located within a department of public works and have used impervious area as the basis for calculating the fee.

As in earlier surveys, revenue generated from stormwater utilities represents a significant source of funds to address stormwater pollution and flooding problems. Most jurisdictions report that utility charges are adequate to meet most administrative costs but not for needs associated with capital improvement programs. Whether stormwater utility fees can be raised at a rate to keep pace with the costs of TMDLs and new water quality criteria remains to be seen.

The Association appreciates the assistance of those who completed the survey instrument. We hope that you find this Report to be of value.






1-1 How is your SWU organized?




2-1 Within which Water Management District is your SWU located?




2-2 What is the basic methodology used for your revenue generation?



2-3 What is the general basis for your fee?




2-4 If impervious area is the fee basis, what is the square footage of your average billing unit (ERU or similar designation)?










Percent of Parcel Data Acquired from Air Photos






Percent of Parcel Data Acquired from Other Sources


3-13 Does your jurisdiction monitor improvements in water quality?




3-14 Does your jurisdiction monitor improvements in flood protection?





3-15 What percentage of your jurisdiction's stormwater facilities are mapped and inventoried?




3-16 Estimate the number of employees (FTEs) and the percentage of your total stormwater program's annual budget allocated to the following program categories:














3-17 For Operations and Maintenance (field) personnel, how many received formal training or certification (from FSA, FDEP, FWPCOA, etc.)?




3-18 Is the stormwater fee revenue sufficient to address the following program areas?








3-19 Does your utility manage the FEMA community rating system flood management program for your jurisdiction?



2018 Survey of Stormwater Utilities

Manual for Establishing Stormwater Utilities in Florida

FSA's Manual "Establishing a Stormwater Utility in Florida" was first published in 1998, and revised in 2003 and 2013. It was initially prepared to assist communities that were considering the development and implementation of a stormwater utility as a means of providing supplemental or alternative funding for their stormwater management program. The current edition is also helpful for those jurisdictions with existing utilities that are considering changes to rates or rate structures. Manuals can be <u>ordered online</u>.
